Release of liability, waiver of claims, assumption of risk and indemnity agreement for the 2007 NOAB rally and related activities, collectively defined as “the EVENT”.

BY SIGNING THIS DOCUMENT YOU WILL WAIVE CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE. PLEASE READ CAREFULLY.

In full or partial consideration for allowing me to participate in all related activities of the *EVENT*, I, the undersigned, hereby warrant and agree that:

1. I am familiar with and accept the risk of serious injury or death from participation in all forms of motor sports and in particular in being allowed to enter this *EVENT*; and
2. I have satisfied my self that I am physically, emotionally and mentally able to participate in this *EVENT*, and that my protective clothing, gear and equipment is fit and appropriate for my role as a participant in this *EVENT*; and
3. I understand that all applicable rules, as amended from time to time, for my participation must be followed, regardless of my role, and that at all times during the *EVENT* the sole responsibility for my personal safety remains with me; and
4. I will immediately remove myself from participation, and notify the organizer, if at any time I sense or observe any hazard or unsafe condition, or if I feel that I have experienced any deterioration in my physical, emotional or mental fitness, or that of protective clothing, gear, or equipment, for continued safe participation in the *EVENT*.

I UNDERSTAND AND AGREE, ON BEHALF OF MYSELF, MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN THAT MY EXECUTION OF THIS DOCUMENT CONSTITUTES:

1. **AN UNQUALIFIED ASSUMPTION BY ME OF ALL RISKS** associated with my participation in the *EVENT* even if arising from negligence or gross negligence, including any compounding or aggravation of injuries caused by negligent rescue operations or procedures, of the *RELEASEES*, as that term is defined below, and any persons associated therewith or otherwise participating in the *EVENT* in any capacity; and
2. **A FULL AND FINAL RELEASE AND WAIVER OF LIABILITY AND ALL CLAIMS** that I have, or may in the future have, against any person(s), entities or organization(s) associated in any way with the *EVENT* including, Mark Van Horn and family, any agency of the Commonwealth of Pennsylvania, private businesses, the residents of the Commonwealth of Pennsylvania, property owners and lessees, promoters, motorcycle associations or any subdivision thereof, advertisers, car owners and other participants, rescue personnel, underwriters, consultants and others who give recommendations, directions or instructions or engage in risk evaluation and loss control activities regarding the *EVENT* or event premises, or any one or more of them and their respective directors, officers, employees, contractors, agents and representatives (all of whom are collectively referred to as “the *RELEASEES*”) from any and all liability for any loss, damage, injury or expense that I may suffer as a result of my use of or presence at the event facilities or my participation in any part of, or my presence in any capacity at, the *EVENT*, due to any cause whatsoever, **INCLUDING NEGLIGENCE, GROSS NEGLIGENCE, BREACH OF CONTRACT, OR BREACH OF ANY STATUTE OR OTHER DUTY OF CARE ON THE PART OF THE *RELEASEES***; and
3. **AN AGREEMENT NOT TO SUE THE *RELEASEES*** for any loss, injury, cost or damages of any form or type howsoever caused or arising, and whether directly or indirectly from my participation in any aspect(s) of the *EVENT*; and
4. **AN AGREEMENT TO INDEMNIFY**, and to **SAVE and HOLD HARMLESS** the *RELEASEES*, and each of them, from any litigation expense, legal fees, liability, damage, award or cost, or any form or type whatsoever, they may incur due to any claim made against them or any

one of them by me or on my behalf, or that of my estate, whether the claim is based on the negligence or the gross negligence of the **RELEASEES** or otherwise as stated above; and
 5. **AN AGREEMENT** that this document be governed by the law, and in the courts of the Commonwealth of Pennsylvania.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN SUBSTANTIAL LEGAL RIGHTS WHICH I AND MY HEIRS, NEXT OF KIN, EXECUTORS, ADMINISTRATORS AND ASSIGNS MAY HAVE AGAINST THE RELEASEES.
